Molina Healthcare of New Mexico provides Centennial Care coverage for “Naloxone Rescue Kits”, which are to be billed by pharmacies. This “kit” is not commercially available, but consists of the following dispensed as one service:

- The commercially-available Naloxone HCl 1 mg/mL, 2 x 2 mL as pre-filled Luer-Lock needless syringes;
- One commercially-available LMA<sup>®</sup> MAD Nasal<sup>™</sup> Intranasal Mucosal Atomization Device (pictured);

- Patient/caregiver training by pharmacist.

**Coverage of Naloxone Rescue Kit****CLAIMS SUBMISSION INFORMATION**

When submitting claims for the Naloxone Rescue Kit, the pharmacy should bill NDC 76329-3369-01. No additional input is needed by the pharmacy. All claims for this NDC will adjudicate with a dispensing fee of \$20.00 (in addition to the contracted drug dispensing fee) to account for the atomizer, educational materials and patient/caregiver training by the pharmacist.

**PROCESSING:**

Submit the appropriate quantity (i.e. "4") and the appropriate day supply (i.e."1") – inappropriate quantities or days supply may cause the claim to reject.
