In conjunction with the New Mexico Pharmacists Association's annual meeting, we are asking for monetary donations or raffle prizes to raise money to be used for the 2017 New Mexico Pharmacy Wholesalers' Invitational Golf Tournament benefitting the New Mexico Pharmaceutical Care Foundation and the UNM College of Pharmacy Student Scholarship Fund.

Two-thirds of the proceeds raised at the Golf Tournament are donated to the College to assist student participation at national pharmacy meetings and to provide two scholarships. One third is retained by the NM Pharmaceutical Care Foundation for other program funding.

The annual contribution to the UNM COP fund has consistently increased with each year. And we are incredibly grateful for the support we have received. The New Mexico Pharmacists Association assists in the planning and hosting of the tournament but does not benefit financially.

NM Pharmaceutical Foundation Activities:

1. Participating Pharmacists and Student Pharmacists from the University of New Mexico College of Pharmacy provide medication review programs at events around the state. In past years, this has included the Annual New Mexico Senior Olympics, the Annual Seniors Program at Glorieta, Prime Time Expo, City of Albuquerque Employees Health Fair, etc. These programs are arranged in cooperation with the New Mexico Aging and Long Term Services Department (formerly Agency on Aging).
2. The Foundation managed a NM Department of Health grant for ten years which provided "Tobacco Cessation" through community pharmacies around the state of New Mexico. Pharmacists that participated in this grant opportunity were able to provide the counseling and necessary medications to patients in more than ten communities. This program still provides online education about cessation counseling to any interested pharmacist.

The purpose of the New Mexico Pharmaceutical Care Foundation is to provide resources for pharmacy education, research, projects in pharmaceutical care and disease management, education for pharmacists, pharmacy technicians and the public, and community screening and public health projects related to pharmaceutical care.

The mission of the UNM College of Pharmacy is to develop innovative leaders in pharmaceutical care and research who enhance the quality of life for the people of New Mexico.
